DSS Services Presentation: DSS presented on their services division, including Child & Adult Protective Services, the Child Advocacy Center, In-Home Family Services, and Out Of Home Services. Please **CLICK HERE** for their presentation.

Provider Updates:

- **-Community Mediation Center of Calvert-** CMCC has a grant to provide conflict resolution services in CCPS. We are taking referrals from all schools in the county for mediation, classroom circles, dialogue circles, and group facilitations.
- **-Pathways Vocational Program-** Taking referrals to help folks with obtaining and maintaining employment

- **-Cornerstone-** TCM, PRP, and RRP programs are all taking referrals. The IHIP-C program is fully staffed and taking referrals and looking to expand the children's side of PRP. Porterhouse has 5 beds for Residential Crisis Services and is taking referrals as well as the ACT team.
- **-Center for Children-** The medication management program is accepting commercial insurance. The office is also onboarding a new therapist which will open up MA slots for therapy. Current openings in Care Coordination and PRP programs as well.
- -State Care Coordination- Offers Care Coordination to Calvert residents with a SUD currently enrolled in treatment services. MDRN funding available to assist with the first 2 months of rent in sober living. The program is currently accepting referrals.
- **-CHMC** Farmer markets open on Tuesday from 230-630pm and Health Expos are upcoming in the summer! The Mobile Health Unit calendar for May and June to come.
- -Maryland's Commitment to Veterans- Staff are available to connect veterans to BH resources, peer services, and inpatient and outpatient therapy. Funding has run out at this time for crisis funding.
