### **LBHA Updates:**

The LBHA staff have provided some important <u>updates</u> regarding various initiatives and developments within the department.

# **Healthy Beginnings:**

Keri-Jo Bobo gave a presentation on the Healthy Beginnings Program, which provides case management, peer support, and support groups for pregnant individuals. Eligibility for this program includes pregnant individuals who are experiencing homelessness, current or history of a substance use disorder, has a diagnosed mental illness, or tobacco/vape usage.

### CalvertHealth Behavioral Health:

Kristi Burns and Alisha Johnson shared the behavioral health services offered at Calvert Health Medical Center offered to individuals ages 13+. They offer 3 levels of care; Inpatient Hospitalization, Partial Hospitalization Program (PHP), and Emergency Psychiatric Services to stabilize, support, and refer patients to community resources.

# **Community Crisis Services Inc. (CCSI)**

In collaboration with the LBHA, Dept. of Public Safety, and County Government, an MOU has been signed to integrate 988 and 911. This will allow for more seamless collaboration between 911 dispatch and the 988 call center to assist Calvert residents in receiving timely access to behavioral health care when in a behavioral health crisis.

### **Department of Parole and Probation**

Jason Dubard shared that the Department of Parole and Probation has begun hiring social workers for community supervision. Jason also introduced Maya Pierre, who was recently hired as a social worker with the agency.

# **Pathways Strong Families Program**

Gregory Holtz shared that Pathways will be hosting a Back to School Family Celebration in partnership with the Maryland Family Network. The event will take place on Saturday August 9th from 11am-3:00pm at 44065 Airport View Drive, Hollywood, MD 20636.
